This law, signed on February 15, 2019, amends the Afghan SIV program by adding 4,000 additional visas, conditioned on the development and implementation of a prioritization process for Afghan special immigrant visas and the submission of three reports to the appropriate congressional committees.

The Afghan Allies Protection Act of 2009, Section 602(b), authorizes the issuance of up to 1,500 Special Immigrant Visas (SIVs) annually through September 30, 2014 to Afghan nationals who have worked for or on behalf of the U.S. Government in Afghanistan and who meet certain requirements.

Petition and Application Processing. If an immigrant visa is immediately available, you may generally file your Form I-360 and Form I-485 at the same time. Immigrant visas for SIVs come from the employment-based fourth preference (EB-4) immigrant visa category for special immigrants.

### Afghan SIV application guide with document samples

If during the SIV processing, the children become 21 years old before you submit the i-360 form, then they are not eligible for SIV visa under the parent case anymore. If they are younger than 21 years old at the time of submitting i-360 form, then they are eligible to get visa issued through the Child Status Protection Act (CSPA) immigration law as long as they remain single, unmarried.

### Special Immigrant Visa Backgrounder

An individual with an approved petition and a priority date that is current for processing (when applicable) is eligible to apply for an immigrant visa or K nonimmigrant visa. U.S. immigration law also provides for a class of immigrants known as "diversity immigrants," from countries with historically low rates of immigration to the United States.

To apply under the SIV programs for Iraqis or Afghans, a prospective special immigrant must submit a petition to the Department of Homeland Security; be otherwise eligible for an immigrant visa; and be otherwise admissible to the United States.
